

DECLARATION OF AWARENESS TO ASSUME RISK AND RELEASE OF LIABILITY
PATENT: TransAlp Rando 1200 km or 600 km

I, the undersigned, hereby apply to be enrolled in the **TransAlp Rando 1200 km or 600 km patent**, starting and finishing in Verona. The patent is organised by **Sport Verona ASD** on the dates **1 - 6 June 2022**.

To this end, **I SELF CERTIFY and DECLARE**
assuming all CRIMINAL AND CIVIL LIABILITY
in the event of reckless, irresponsible and/or false declarations:

- I have read and carefully evaluated the description of the randonnée available as a pdf file on the relative web page and consequently I know, as far as possible, the route, the altitudes, the difficulties and the dangers and I am **fully aware of the risks involved** in participating in the randonnée as an "individual excursion" and therefore in a regime of **total autonomy and self-sufficiency**; without any support or type of assistance. I fully assume these risks, including minimal rest, night-time riding the possible presence of animals on the route, possible severe weather conditions, orientation problems, physical and mental fatigue, the risk of being injured and/or incapacitated in a place where medical assistance may not be possible in time to prevent fatal injury. I have therefore considered that I **have the personal experience and psycho-physical capacity for autonomy to be able to manage the difficulties** I may encounter in finding water, food and areas of refuge or rest.
- To have read carefully and understood in full the Regulations which can be found as a pdf file on the relative web page of the Randonnée Patent and the A.R.I. Regulations and to accept them in every part without reservation.
- That I am **aware of the absence of any technical support and assistance**, not even medical assistance; and that **in the event of my withdrawal**, I will have to arrange for my own return and that of my vehicle.
- I acknowledge my obligation to wear a rigid, homologated **protective helmet** and to comply with the Italian, Austrian and Slovenian Highway Code, and to maintain the condition of my bicycle at all times in accordance with what is prescribed therein, particularly with regard to the braking and lighting system. To this end I declare that I have checked that the **efficiency of the braking system, and in general of my bicycle, is optimal** and that I am solely responsible for this.
- To **recognise the organiser's** unquestionable right to **modify the route** at any time, or to **cancel or suspend the Randonnée**, should **safety reasons** advise this.
- To exempt the organiser, due to the particular length of the course, from any obligation of permanent and/or current control of the course.
- To recognise and acknowledge that the only legal obligation assumed by the Organiser towards me is to organise controls for the validation of the "travel card". Both the declared controls and the secret controls have the sole function of verifying compliance with the route in order to homologate the patent.
- To release the Organiser, his staff and collaborators, from any contractual and extra-contractual responsibility, in relation to participation in the Randonnée Patent, for any damage and/or injury and/or loss suffered by me, my vehicle or my equipment or caused to others, persons or things, due to my conduct, whatever the cause; including any legal costs.
- To have the **obligation** to immediately **inform** the Organiser of my **withdrawal** or, at the end of the maximum arrival time, **my delay**, knowing that in the absence of news, the Police will be alerted with costs and responsibilities at my own expense.
- To recognise to the organiser the right I have authorised to **use, free of charge**, without territorial or time limits, **still or moving images of me** during the Randonnée, as well as to publish my name on the event website in the list of participants and, if I complete the trial, of the patented ones.

With regard to the protection of "Privacy" I also declare that I have received full information about the use of my personal data and I give my consent to their treatment exclusively for the purposes of carrying out the activity related to the Randonnée Patent above.
